OFFICIAL RULES

*An eligible Participant also can receive a Wheel Spin Opportunity without purchasing instore items by following the directions listed under "Mail-in".

ONLINE: Participants will take valid receipt transaction code to <u>terribleherbst.com/terribles365</u> (the "Website") during the Sweepstakes Period and complete the online entry form in its entirety to include first name, last name, state of residence, birth date, phone number and email address. The Sweepstakes Period is divided into four (4) Contest Periods.
